Notice of Hearing Surveys Act, R.S.O. 1990, Chapter S.30

IN THE MATTER of an application under Section 48 of the *Surveys Act*, R.S.O. 1990, Chapter S.30 by the Corporation of the Township of Tiny for a Municipal Resurvey of the Road Allowance between Concessions 18 and 19, across Lots 9, 10, 11 and 12 and Part of Lot 13, Geographic Township of Tiny, County of Simcoe.

AND IN THE MATTER of a Survey Report and Plan of Survey to re-establish and mark with permanent monuments, the Road Allowance between Concessions 18 and 19, across Lots 9, 10, 11 and 12 and Part of Lot 13, Township of Tiny, County of Simcoe by John Goltz, Ontario Land Surveyor, dated August 30, 2011.

NOTICE is hereby given that a hearing to confirm the above noted Municipal Resurvey will be held on **Wednesday, November 28, 2012 at 9:00 a.m.** and will continue into **Thursday and Friday November 29th and 30th, 2012** respectively as required. The hearing will be held at:

Any objections will be made available to persons who have self-identified as an interested party.

In accordance with the Act, all affected parties will be afforded the opportunity to be heard concerning the confirmation of the survey. This hearing is to confirm the limits of the road allowance between Concession 18 and 19 only. The tribunal will not hear or address issues that pertain to title or acquired interests.

Any party requiring French translation services must notify the Office of the Surveyor General on or before **September 24, 2012**.

If a party does not attend at the hearing, the tribunal may proceed in the party's absence and the party will not be entitled to any further notice in the proceeding.

In the event that no objections are filed or brought forward at the hearing, the survey will be confirmed in accordance with the provisions of the *Surveys Act*, R.S.O. 1990, Chapter S.30.

Personal information is collected under the authority of the *Surveys Act* and *Public Enquiries Act*. Your name, property location and the nature of your objection may be included in the final decision that is distributed to participants present at the hearing. Contact information will be used to provide a copy of the decision and confirmed Plan to every person who appeared at the hearing and is documented in the transcript.
