BY-LAW NUMBER 21-011

Being a By-law to amend Parking By-law 20-015

WHEREAS By-law 20-015, passed the 10th day of February 2020 establishes the regulations for the parking of vehicles within the Township of Tiny;

AND WHEREAS it is deemed necessary to amend the said By-law to implement changes to the parking system currently in place to further identify emergency access roads;

NOW THEREFORE the Council for The Corporation of the Township of Tiny hereby enacts as follows:

1. That By-law 20-015, Schedule "C", PERMIT PARKING SIGNS ON DISPLAY AT THE ENTRANCE TO NEIGHBOURHOODS is hereby amended by updating Schedule "C" to include the following:

2. That By-law Number 20-015, Section E., PERMIT PARKING, Subsection 4. (g), is deleted in its entirety and replaced with the following:

(g) That parking permit shall be valid from the 15th day of April until the 15th day of October for the year of issue;

3. That By-law Number 20-015, Section G., PENALTIES, Subsection 5. (b), (c) and (d), are deleted in its entirety and replaced with the following:

(b) Any person who contravenes any section of this by-law, except Sections C.1.(k), C.1.(p), C.2., E.1. or E.2., and is charged by way of Part II of the Provincial Offences Act, may, within seven (7) days of the date the ticket was issued, report to the Municipal Office and make voluntary payment in the amount of Twenty (\$20.00) Dollars in full satisfaction of the alleged offence;

- (c) Any person who contravenes Sections C.1.(p). of this by-law, and is charged by way of Part II of The Provincial Offences Act, may within seven (7) days of the date the ticket was issued, report to the Municipal Office and make voluntary payment in the amount of Fifty (\$50.00) Dollars in full satisfaction of the alleged offences;
 - (d) Any person who contravenes Sections C.1.(k)., C.2.(a)., C.2.(b)., E.1. or E.2. of this by-law, and is charged by way of Part II of The Provincial Offences Act, may within seven (7) days of the date the ticket was issued, report to the Municipal Office and make voluntary payment in the amount of Seventy Five (\$75.00) Dollars in full satisfaction of the alleged offences;
4. That this by-law shall come into force and take effect on the date of passing.

READ A FIRST AND SECOND TIME THIS 3rd DAY OF FEBRUARY 2021.

READ A THIRD TIME AND FINALLY PASSED THIS 3rd DAY OF FEBRUARY 2021.
