Water Treatment and Servicing Master Plan Municipal Class Environmental Assessment Notice of Study Completion

TAKE NOTICE that the Township of Tiny has completed a Master Plan Class Environmental Assessment (Master Plan) for the supply of municipal drinking water to existing and future residents in serviced areas. The Master Plan identifies the preferred solutions to increase the resiliency of the township's 16 municipal drinking water systems and to accommodate the anticipated growth to the year 2045.

The Master Plan was prepared in accordance with the Master Plan requirements following Approach No. 1 of the Municipal Engineers Association (MEA) Municipal Class Environmental Assessment (as amended in 2023). The list of recommended projects with their Class EA Schedules is shown below.
