Dear Sir/Madam:

We have previously communicated to the affected landowners regarding certain land title issues that came to light in relation to the above noted properties. These issues came to the Township's attention as a result of a number of applications made pursuant to the *Boundaries Act* and the Committee of Adjustment.

In order to address the Township's road allowances, being Concessions 6 and 7, the Township has applied to the Minister of Natural Resources for a Municipal Survey pursuant to the provisions of the *Surveys Act*, in particular, those portions of the road allowances as they progress to the water's edge.

In addition, the original Crown Patent provides for a road allowance along the shore in front of the lots of Plan 779. The status, location and implications of this road allowance, amongst other issues require court determination.

As previously advised, the Township commissioned a land survey in this area, which is now complete and available for public viewing at the Township Office. Further, on March 31, 2014, Township Council directed its legal counsel to proceed with a court application in order to address the various title issues (motion attached). This court application will be initiated shortly.

In the meantime, the Township will be taking steps to make the survey results available on the Township website. We understand that many of the property owners have already jointly engaged legal counsel and we hope to be co-ordinating our efforts to allow these long standing title issues to be clarified and resolved.
