The Township's Multi-Year Accessibility Plan and progress reports such as this demonstrate the Township's commitment to making accessibility a part of everyday business.

The Township's Accessibility Advisory Committee (AAC) plays a key role in assisting the Township of Tiny in meeting its accessibility goals. The AAC reviews the multi-year plan on an annual basis to provide recommendations to Council on accessibility matters. The plan is also reviewed annually to highlight the progress made to date.

Accessibility Achievements 2022

- › Promotion of County of Simcoe File of Life Program, a standardized location and form providing quick access to medical information in an emergency situation
- › Promotion of 'Respect the Space' brochure
- › Annual 1-2 km crushed limestone resurfacing of Tiny rail trail
- › Support and promotion of Snow Angels Program Canada Program
- › Launch of new website platform and initiation of project (including compliance with WCAG 2.0 Level AA)
- › Consultation on Balm Beach Work Out Equipment
- › Installation of rolling boardwalk at Concession 13 and Huronia Court
- › Launch and collection of results for Accessibility Public Survey
- › Public input on accessibility features for:
 - Lafontaine Beach Park Washrooms
 - Rolling Boardwalk Locations
 - Parkside Park Exercise Equipment, and
 - Wyevale Park toboggan hill entrance

- Touchless fixtures in public washrooms
- Consultation on Balm Beach walkway feature and design improvements
