## Municipal Law Enforcement Update May 17 to 20, 2024

**Date:** May 21, 2024

**(Tiny, Ontario)** Over the period of May 17 to 20, Township of Tiny By-law Officers were on full patrol responding to calls ranging from fireworks, noise, short-term rentals, and illegal parking complaints.

Offence Type	Charge(s)
<a href="#">Fireworks By-law – set off fireworks on an unauthorized day</a>	1
<a href="#">Noise By-law – cause or permit a noise from any electronic device or other sound-producing equipment</a>	1
<a href="#">Short-Term Rental By-law - Permit the rental of Premise for fewer than 6 consecutive days (April 15 – October 15)</a>	2
<a href="#">Short-Term Rental By-law - Licensee permit more than 2 Renters on the Premises each Bedroom</a>	1

Township By-law Officers patrolled 471km throughout the municipality via bicycles. A total of 69 complaints were responded to for various concerns.
