
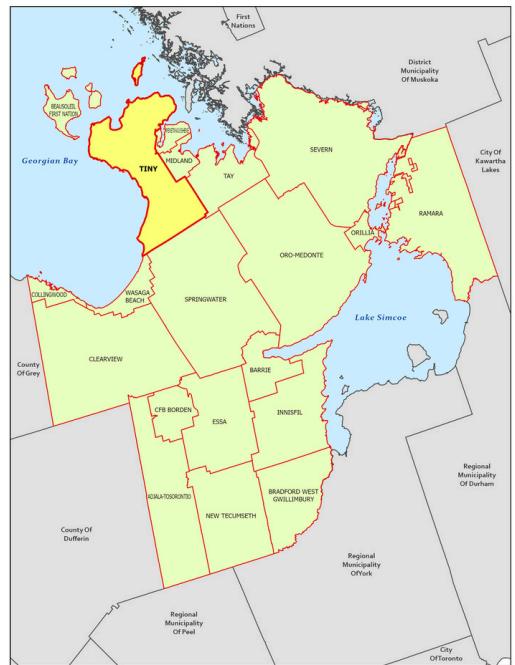


Where We Live

About Tiny

The Township of Tiny is situated at the southern tip of Georgian Bay at the northern end of Simcoe County. Tiny's population of almost 13,000 doubles in the summer as the region is a popular destination for both tourism and cottages due to our beautiful waterfront areas and small town appeal.

In addition to being known for our pristine beaches, Tiny is also home to Awenda Provincial Park that has over 2,900 hectares of forested land on the shores of Georgian Bay, 31km of trails, and 17km of backcountry ski trails in winter.

Tiny is rich in culture and history, with ties to First Nation, French, and British peoples. In addition to the mainland, the township also includes most of Giant's Tomb Island. The region is also known for farming, as seen by the 94 farms across the township that occupy well over 17K acres of farmland.

Tiny is big on community, which is why we host several signature events annually, such as the Winter Carnaval d'Hiver, Senior Symposium, Mayor's Charity Golf Tournament, Community BBQ, Farm Crawl, and Tree Lighting Celebration.

Our community has many qualities to be proud of such as being designated as:

- An Age-Friendly Community by the World Health Organization for the township's commitment to being inclusive of all ages and abilities. We offer a wide variety of recreational programs and have made strides to improve our parks and facilities.
- A Bee City, which helps to showcase our commitment to protecting pollinators. Supporting pollinators fosters environmental awareness and sustainability, and increases interactions and engagement among community stewards.
- A Blue Community - in order to receive this designation, a municipality must recognize water as a human right, ban the sale of bottled water in civic spaces and support the public ownership of water utilities. Tiny is the first Blue Community in Ontario, and third in all of Canada. As part of our commitment to being a Blue Community, the township has installed several water fill stations at various parks, facilities, and beaches across the township.



Municipal Budgets



What is a Municipal Budget?

The Township of Tiny's municipal budget is a financial plan that aims to estimate the costs, revenues, and resources the township will need over time. It also serves to forecast future financial needs by analyzing trends and the needs of our community.

There are two key components of a municipal budget:

Operating Budget



The Operating Budget is funding for the day-to-day operations consumed within one year, such as:

- maintenance activities
- service contracts such as policing and libraries
- utilities
- materials and supplies
- salaries/wages
- licensing
- administrative services

Capital Budget



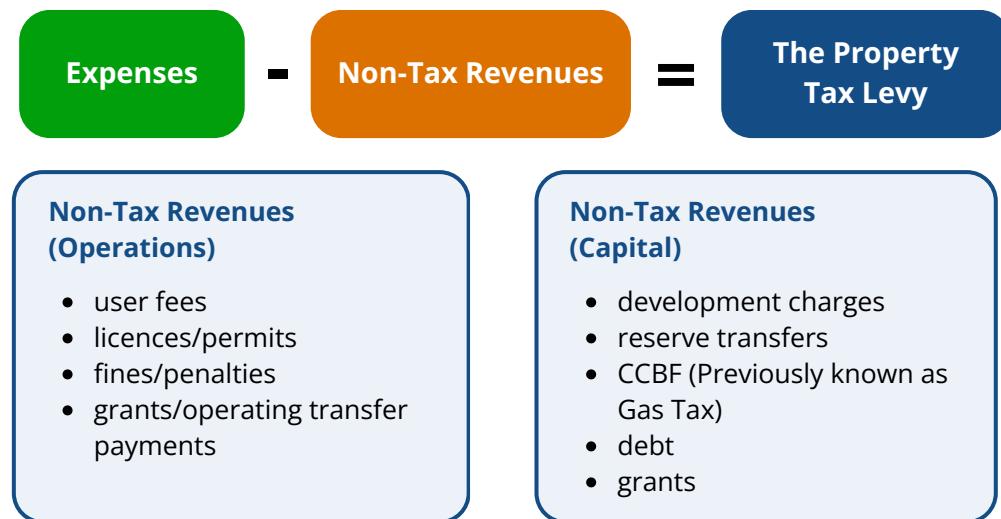
The Capital Budget is funding for infrastructure, assets, or other items that have lasting benefits beyond one year, such as:

- roads/sidewalks
- parks/trails
- facility upkeep
- asset management
- water pipes/pump-houses
- technology assets
- fire apparatus



Components of a Municipal Budget

The biggest challenge of preparing a municipal budget is achieving a balance between matching services to the needs of the community, and the means to fund the services.

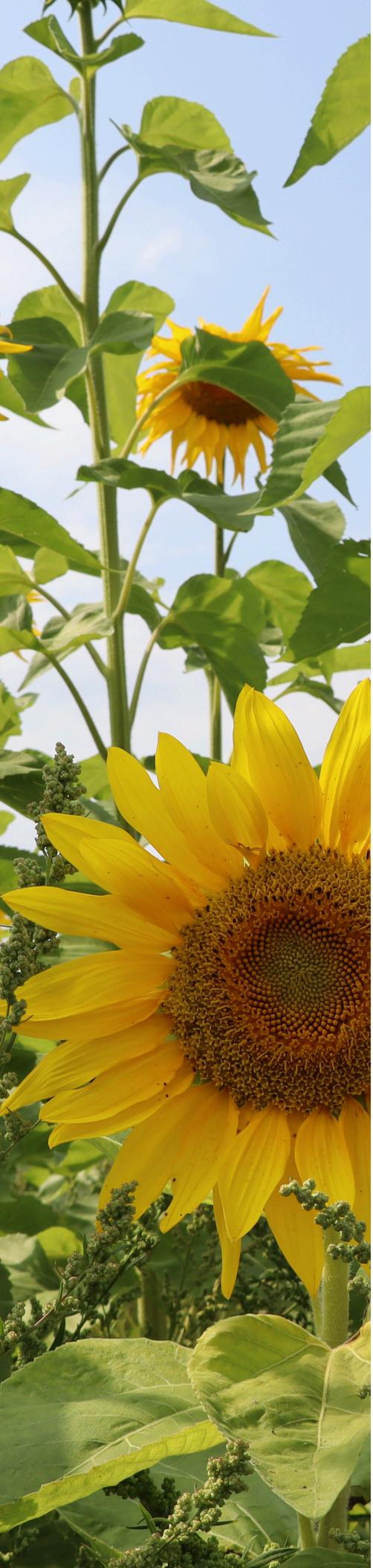


The township's Council is required to approve a balanced budget each fiscal year that must be finalized and approved prior to the issuance of final property tax bills.

The operating budget includes annual expenditures for personnel costs, materials and supplies, contracted services, minor capital, debt charges (if applicable), reserve transfers and program fees.

The township's capital budget includes expenditures and financing (if applicable) to funding sources to acquire, construct, maintain and facilitate township capital assets such as: roads, bridges/structures, water systems, recreational facilities, and administrative facilities.





Legislative Requirements for Municipal Budgets

Municipal Act

Section 290(1) of the Act states: "for each year, a local municipality shall, in the year or the immediately preceding year, prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality, including:

- a) Amounts sufficient to pay all debts of the municipality falling due within the year;
- b) Amounts required to be raised for sinking funds or retirement funds; and,
- c) Amounts required for any board, commission or other body.

Section 291 of the Act permits municipalities to prepare and adopt a budget covering a period of two-to-five years. If the first year of a multi-year budget immediately follows a year in which a regular budget applies.

Ontario Regulation

Ontario Regulation 284/09, Budget Matter Expenses, states that the municipal budget may exclude some "non-cash" expenses such as amortization, post-employment benefits, and solid waste landfill closure and post-closure liabilities

Basis of Accounting



The Township of Tiny's financial statements are prepared and presented in accordance with the Generally Accepted Accounting Principles (GAAP) for local governments as recommended by the Public Sector Accounting Board (PSAB). Preparation of financial information follows the Chartered Professional Accountants of Canada (CPA Canada) Public Sector Accounting Handbook.

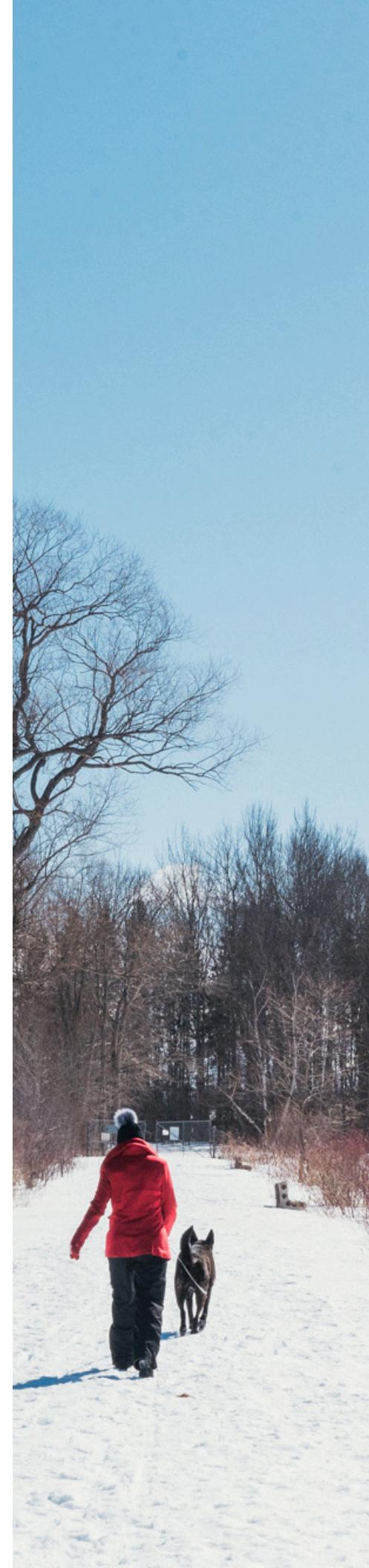
The Township of Tiny follows the accrual basis of accounting, which recognizes revenues when they occur and expenditures when they are incurred, even if cash receipts and payments occur in different periods. Per the CPA Canada Public Sector Handbook section 1200 "Financial Statement Presentation" and section 3150 "Tangible Capital Assets," the township provides details on their Tangible Capital Assets, namely: their historical cost, accumulated amortization, and an amount charged to operations that represents the value of the assets that have been used up, amortization expense.

The township's Budget does not include a charge for amortization. This effectively understates the reported cost of the programs and services described in the budget.
