NOTE: An "occurrence is when a Municipal Law Enforcement Officer responds to any complaint (whether it is determined that a by-law violation has occurred or not), or when doing pro-active enforcement and a violation of a by-law has occurred.

From 2024 to 2025 the number of complaints have decreased over the second quarter time period. Staff analyzed the differences and would draw the following conclusion:

Short-Term Rentals: Over the course of the second quarter, the By-law Department received 66 complaints related to Short-Term Rental properties which is a decrease from 104 complaints in 2024, and further decrease from 122 complaints in 2023.

Dogs Prohibited on Balm Beach Reminder

A reminder to the community that as per By-law #02-115 dogs are prohibited on Balm Beach between June 1 and September 30.

Temporary Beach Encroachments

Residents and visitors are reminded that personal items/private property cannot be left unattended or on municipally owned property overnight. Personal property also cannot be stored on municipal property. Examples of personal items include but are not limited to: chairs, tables, watercraft, boats and their launches/docks/lifts, decks/platforms, fire pits, umbrellas and tents, kayaks, and paddleboards.

Personal items left on municipal property will be labelled with a yellow warning tag and must be removed within seven calendar days. Where a tagged item is not removed within seven calendar days, the municipality will remove the items and store them at a municipal facility to allow property owners to recover their items. If the items at the municipal facility are not claimed by the owner within 30 days, the items will be disposed of.



Noise Control By-law

The Township of Tiny would like to remind the community that <u>Noise Control By-law #21-028</u>, Section 3.1 states: "No person shall emit or cause or permit the emission of noise resulting from activity listed in Schedule "A" if clearly audible at a point of reception." The following are two examples of complaints commonly reported to the municipality:

- The operation of any electronic device or group of connected electronic devices incorporating one or more loudspeakers or other electromechanical transducers, and intended for the production, reproduction, or amplification of sound;
- Persistent barking, calling or whining or other similar persistent noise made by any domestic pet or any other animal kept or used for any purpose other than agriculture.

Concerns regarding non-compliance can be reported to the Municipal Law Enforcement Department at 705-526-4204.



Roadside Debris

Please be reminded that roadside debris (i.e. broken chairs, old furniture and tables, old BBQ, scrap metal, etc.) is not permitted on the road allowance as there is no free pickup. Items that are left on the roadside will be issued a yellow sticker requiring their removal within 72 hours. Items remaining after 72 hours may be picked up by Township of Tiny staff, disposed of, and a Non-Compliant Waste Service Fee of \$180 will be applied.

Residents are encouraged to take waste to the County of Simcoe's North Simcoe Transfer Station, 1700 Golf Link Road, Midland, (Monday – Saturday 8:30 a.m. – 4:30 p.m.).





Fireworks Permitted only on Canada Day!

With the upcoming Canada Day Holiday approaching, the Township of Tiny would like to remind the community that Fireworks By-law 07-054, prohibits the display of and setting off of fireworks outside of Victoria Day, Canada Day, New Year's Eve, and New Year's Day. Therefore, the discharge of fireworks is strictly prohibited within the municipality outside of these four days.

Concerns regarding non-compliance and specific details of the address where the violation is occurring can be reported to the Municipal Law Enforcement Department at 705-526-4204. Non-compliance may result in the issuance of a warning, a charge with fines ranging from \$365.00 to \$100,000.00, or a summons to appear in court




