

THE CORPORATION OF THE TOWNSHIP OF TINY

BY-LAW NUMBER 26-033

Being a By-law to amend Parking By-law 20-015

WHEREAS By-law 20-015, passed the 10th day of February 2020 establishes the regulations for the parking of vehicles within the Township of Tiny;

AND WHEREAS it is deemed necessary to amend the said By-law to implement changes to the parking system currently in place to implement APP only paid parking systems and a change to the Permit Parking system;

NOW THEREFORE the Council for The Corporation of the Township of Tiny hereby enacts as follows:

1. That By-law 20-015, Section A., DEFINITIONS, is hereby amended by inserting following:
 23. **“Mobile Payment Application”** includes a mobile payment application or web-based platform, for the purpose of controlling and regulating the Parking of a Vehicle in a Paid Parking Zone and which facilitates payment for Parking in a Paid Parking Zone through a mobile device;
 24. **“Paid Parking Zone”** means a Highway or Township Parking Area where Parking is controlled and regulated through a Parking Payment Device;
 25. **“Parking Payment Device”** includes,
 - (a) a Parking Machine, or,
 - (b) a Mobile Payment Application.
2. That By-law 20-015, Section D., RESTRICTIVE PARKING, Subsection 1. and Subsection 2. are hereby deleted in its entirety and replaced with the following:
 1. (a) Between the 15th day of May through to the 15th day of September each year and between the hours of 8:00 a.m. to 10:00 p.m., no person shall park a vehicle, on a highway or part of a highway, Paid Parking Zone as listed below, unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-Law, for each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.
 - (i) Concession Road 2 West (north side) from Tiny Beaches Road South westerly to the limit of the roadway.
 - (ii) Rue Lafontaine Road West (south side) from Marchand Road westerly to Tiny Beaches Road North.
 - 1.(b) Between the 15th day of May through to the 15th day of September each year and between the hours of 5:00 a.m. to 10:00 p.m., no person shall park a vehicle, on a highway or part of a highway, Paid Parking Zone as listed below, unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-Law, for each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.

- (i) Balm Beach Road West (northwest side) from Tiny Beaches Road North to Boblyn Road.
- 1.(c) Between the 15th day of May through to the 15th day of September each year and between the hours of 5:00 a.m. to 10:00 p.m. on Saturdays and Sundays and Holidays, and between the hours of 9:00 a.m. to 5:00 p.m. on Monday through Friday, no person shall park a vehicle, on a highway or part of a highway, Paid Parking Zone as listed below, unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-Law, for each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.
 - (i) Tiny Beaches Road North (southwest side) from Balm Beach Road West to #18 Tiny Beaches Road North.
 - (ii) Oliver Drive (northwest side) in front of #2 Oliver Drive
- 2.(a) Between the 15th day of May through to the 15th day of September each year and between the hours of 5:00 a.m. to 10:00 p.m., no person shall park any vehicle in a Paid Parking Zone in the "JACKSON PARK PARKING LOT" or at "PARENT PARK PARKING LOT" unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-law, each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.
- 2.(b) Between the 15th day of May through to the 15th day of September each year and between the hours of 5:00 a.m. to 10:00 p.m. on Saturdays and Sundays and Holidays, and between the hours of 9:00 a.m. to 5:00 p.m. on Monday through Friday, no person shall park any vehicle in a Paid Parking Zone in the "#18 TINY BEACHES ROAD NORTH" or at "#5 PARKSIDE DRIVE" unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-law, each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.
- 2.(c) Between the 15th day of May through to the 15th day of September each year and between the hours of 8:00 a.m. to 10:00 p.m., no person shall park any vehicle at the Paid Parking Zone parking lot at "#2020 TINY BEACHES ROAD SOUTH" or at "775 RUE LAFONTAINE ROAD WEST" unless the driver of such vehicle pays the required fee as set out in the Townships Fee Schedule By-law, each day, for each parking space used, into the Parking Payment Device and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.
- 3. That By-law 20-015, Section D., RESTRICTIVE PARKING, is hereby amended by inserting the following:
 - 16). No Person shall Park a Vehicle in a Parking Space within a Paid Parking Zone, listed in Section D., Subsection 1 or Subsection 2., unless the applicable fee has been paid through the Parking Payment Device controlling such Parking Space and, where required, a validation receipt is clearly displayed on the dashboard of the Vehicle.

17. No Person shall Park a Vehicle in a Paid Parking Zone Parking Space, listed in Section D., Subsection 1 or Subsection 2., where the validation receipt displayed is expired or the period paid through a Mobile Payment Application has expired.
4. That By-law 20-015, Section E., PERMIT PARKING, Subsection 4., (l), is deleted in its entirety and replaced with the following:
 - (l) valid Parking Permits are exempt for paying for parking in a Paid Parking Zone as set out in Section D., Subsection 1 or Subsection 2., of this By-law.
5. That By-law 20-015, Section E., PERMIT PARKING, Subsection 4. (g), is deleted in its entirety and replaced with the following:
 - (g) That Parking Permit(s) shall be valid from the 14th day of May until the 15th day of September for the year of issue;
6. That this By-law shall come into force and take effect on the date of passing by the Council of the Township of Tiny.
